Race fans can expect to see noteworthy veterans, such as Rusty Wallace and Sterling Marlin, back on track for the new NASCAR® Nextel Cup season. Meanwhile, newer faces, including current NASCAR® Winston Cup Rookie of the Year contender Jamie McMurray, will show off a year's worth of high-speed experience as they continue to build their racing resumes. In addition, Dale Earnhardt Jr. will return to NASCAR® Busch Series racing in 2004, kicking things off with the season-opener at Daytona International Speedway. SHIFT INTO A CORVETTE

This limited-edition 1:12-scale No. 3 GM Goodwrench Service Plus Chevrolet Corvette C5-R is a replica of the model driven by Dale Earnhardt, Dale Earnhardt Jr. and veteran drivers Andy Pilgrim and Kelly Collins during the Rolex 24 Hours of Daytona endurance race on Feb. 3-4, 2001 at Daytona International Speedway. The sports car event was a first for both NASCAR® champions Dale Earnhardt and Dale Jr.

Despite some setbacks caused by two lengthy fix-it pit stops, the foursome brought the No. 3 Corvette C5-R within two laps of a podium finish, completing 642 of 656 laps for fourth place overall and second place in the GTS class.
